Sub: Requesting to help in ABC camp for stray dogs Reg.

Respected Sir,

Greetings.

We are a group of individuals residing in Thiruvanai Kovil area in Trichy. We are taking care of our Indian Desi stray dogs those belong to our area. We used to feed them and take care of their health. We also involve ourselves in the rescue operations if we get any call from our area. We have also treated a stray dog from distemper by using neurobion and geramycin each 2ml daily for a month. Now that dog is living happily with no danger.

The Purpose of this petition is that, to conduct the ABC camp for stray dog as per the G.O. in Tiruchirapalli.

I approached my Trichy city corporation for conducting the ABC camp. Our doctors team is from International Animal Rescue, run by Dr. A Jothyraj (9442176508). They have catchers and kennels for this process. More over to the added advantage they have been doing the same process of ABC camp for the corporation for years. But now he has stopped as there is price difference in sanction of the fund per dog. The G.O. MS.No 181 also says Rs700/- per dog. But the corporation are rigid in the price that they wont permit beyond Rs.445/-.

Being animal activist and pet lover we approached the CHO (Mr. T.Mariappan) but he strictly confirmed that I can place the order only if anyone willing to do for Rs.445/-. He told us that the corporation has the right to shoot and kill any dogs which is without a license or collar belt or without the owner under section 22. We were not in a mood to go for a deep argument as we want some good thing to happen for stays.

We were in search of any organization who can perform the ABC for the prescribed amount. But none were ready. So I went to report the same to CHO (Mr. T. Mariappan), but he got transferred and another one officer was holding that position (Smt. Rajalakshmi). Her sub-ordinate (Mr.Guru) also gave same information but when we spoke about the G.O reference, he asked us to bring. We went with G.O copy but objected the same that he haven't received any updation and can't accept it. He told us that he will allow only Rs.441/-. This incident happened on 26th June 2015.

The ABC was stopped for the past 1 year, but the corporation people are catching the dogs with strings and we don't know where they are taking them and what they are doing.

Kindly help us and thanks for the same in advance.
